References (prescriptive)

- Bibliography not cited in the text should not be included. Bibliographical citations should be given in the form of references to the text.
- They should be presented alphabetically by the first author's surname (adding the second only if the first author's surname is very commonly used).
- Bibliographical citations should be taken from the original documents, preferably scientific journals and books (to a lesser extent), always indicating the first and last page of the work from which they are taken, with the exception of complete works.
- Given the importance for citation indexes and impact factor calculations, correct citation will be assessed according to these APA 6th edition standards, with national and international references (especially in Portuguese, Spanish and English).
- It is prescriptive that all citations with DOI (Digital Object Identifier System) are reflected in the References, using their full URL.
- Note: All submitted web addresses must be shortened in the manuscript using <https://bitly.com/>.
- References in Times New Roman 11 pt bold and justified (French indent format). Separate from the title by one space (This section is not listed).
